## LAUNCHES DOCUWORKS FOLDER FOR ANDROID 1.0, A FREE APPLICATION TO CARRY DOCUMENTS WITH ANDROID™ OS MOBILE DEVICES

### LINKING WITH FUJI XEROX'S CLOUD SERVICE TO SUPPORT MOBILE WORK

**TOKYO, May 30, 2012** – Fuji Xerox Co., Ltd. today starts offering a free-of-charge application for Android™ OS mobile devices -- DocuWorks Folder for Android 1.0, which enables to carry DocuWorks documents with the Android™ OS devices. The application can be downloaded from Google play or au Market.

DocuWorks Folder for Android 1.0's folder function allows users to take necessary documents out of offices with Android™ OS mobile devices, and the application links to Working Folder<sup>1</sup> --a cloud-based online document sharing service with monthly charge--, with which users can seamlessly share documents, enhancing their mobile work.

In addition to DocuWorks Folder for iOS<sup>2</sup> for iPhones, iPads and iPod touches launched on December 2011, the application now covers Android™ OS mobile devices, which are expanding in the enterprise market.

DocuWorks Folder for Android 1.0 allows users to download or upload files from or to Working Folder (see image 1), as well as to view DocuWorks documents stored in Working Folder with DocuWorks Viewer Light for Android 1.0<sup>3</sup> (see image 2).

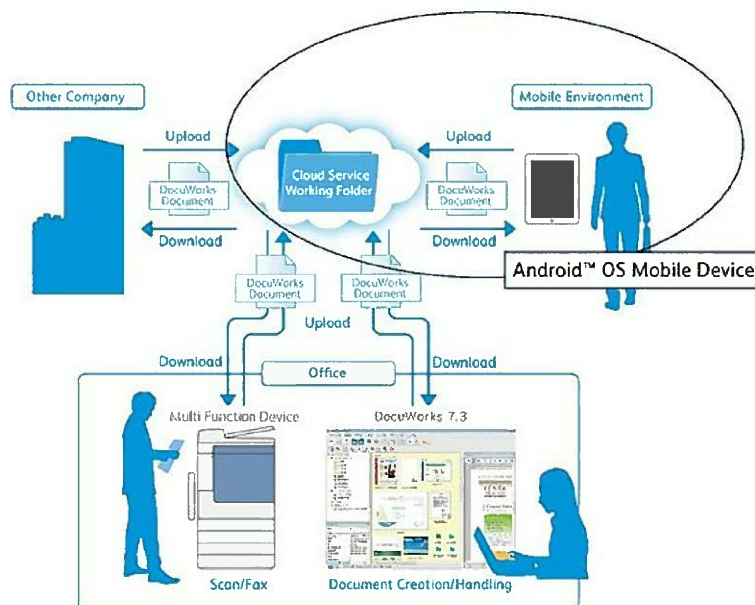

Further, users can build a paperless fax environment using Working Folder; the fax messages received on multifunction devices are converted into DocuWorks files and stored in Working Folder automatically, thus users can view the received messages from their mobile devices while they are out of the offices. This contributes to streamlining the office work and accelerating decision-making processes.

### Features of DocuWorks Folder for Android 1.0

1. DocuWorks Folder for Android 1.0 shows the list of documents stored in Working Folder with cabinet/drawer/folder tree structure. It lists the document names with thumbnails, which show the contents of the documents.
2. Users can rename, move, delete or create folders in Working Folder from their mobile devices. Also, they can download/upload documents in Working Folder from/to Save Folder.
3. Even when they are off-line, users can view the documents in the Save Folder, or change their names or delete them by showing the document list.
