
## FUJI XEROX'S MANUAL CREATION AND MANAGEMENT SOFTWARE NOW OFFERS WEB SEARCH / BROWSE SERVER OPTION

## LAUNCHES APEOS PEMASTER MANUAL WEAVER 2.3 TO STREAMLINE COMPANY REGULATION AND MANUAL CREATION PROCESSES

TOKYO, August 31, 2012 – On September 12, Fuji Xerox Co., Ltd. will release Apeos PEMaster Manual Weaver 2.3--software that streamlines work processes for creating and managing company regulations and workflow manuals--and its Web Search/Browse Server Option for publishing them on intranet as well as for viewing and searching.

With the new option, Apeos PEMaster Manual Weaver 2.3 supports the whole workflow from creation, edit, approval, management to publishing of regulations and manuals. The documents can be edited, saved and managed as structured documents in the eXtensible Markup Language (XML) format, and be batch-converted into HyperText Markeup Language (HTML) or PDF formats for publishing them on an intranet. Through Web Search/Browse Server Option, the latest edition of regulations/manuals can be shared online with branches or other offices. (Fig. 1)

Publishing this type of documents online requires the system investment such as development of individual search engines and servers. However, Web Search/Browse Server Option allows users to introduce the function with lower cost and shorter lead-time. Fuji Xerox has been providing the solutions for creation and management of company regulations and workflow manuals to major banks, insurance companies and other clients, offering services for system development and administration, as well as operation know-how. It plans to expand the solution with the new option to a greater scope of clients including other financial institutes.

Employees of many companies need to refer to regulations/manuals that describe rules, administrative duties, procedures and steps, at high frequency. These documents contain a large number of pages, must be revised immediately when the applicable laws are amended, requiring a massive workload in creation and management.

With requirement for incident accountability and prompt handling of onsite inspections by competent authorities, the development and management of regulations and manuals that standardize work processes and clarify procedures, represent an important business issue in order to avert the risk of operation errors concerning compliance.
